### DISTINGUISHING FEATURES OF THE CLASS: This position involves responsibility

for the administration and coordination of the County-wide Community Policing Unit.

The incumbent will be responsible to ensure the unit provides a minimum of 149

investigations, and to enhance investigations, especially drug related investigations in

order to bring better-prepared cases to prosecution. This individual will be responsible to

provide surveillance and drug interdiction techniques training, along with training on

specific issues and techniques that will improve case preparation for prosecution, to the

police officers assigned to the Community Policing Unit. Work is performed under

general direction of the District Attorney with wide leeway for independently conducting

investigations and otherwise performing the duties of the position.

<u>TYPICAL WORK ACTIVITIES:</u> The typical work activities listed below, while providing representative examples of the variety of work assignments in the title, do not describe any individual position. Incumbents in this title may perform some or all of the following, as well as other related activities not described.

Schedules, coordinates, identifies, leads and conducts confidential investigations with the

police officer members of the Community Policing Unit;

Trains members of the Community Policing Unit on surveillance and drug interdiction

techniques;

Provides insight into specific issues and techniques that will improve case preparation for

prosecution;

Trains members of the Community Policing Unit on specialized surveillance equipment;

Maintains specialized equipment;

Identifies target areas for investigations;

Participates in or conducts undercover investigations of suspected criminal activity;

Consults with trial prosecutor to discuss case facts and history;

Assists in trial preparation by reviewing and evaluating evidence and locating,

transporting and preparing witnesses;

Testifies in criminal proceedings as required;

Prepares reports and correspondence as required;

Responsible for maintaining physical evidence for cases on appeals.

<u>CHARACTERISTICS</u>: Thorough knowledge of criminal investigation procedures, methods and techniques, including interviewing, interrogation, evidence gathering/preservation, and surveillance; thorough knowledge of New York State Laws relating to criminal law enforcement duties, including the Penal Law and the Criminal Procedure Law; thorough knowledge of statutes and case law relating to arrests, rules of evidence, and court procedures; skill in conducting and coordinating criminal investigations; ability to train law enforcement personnel in the procedures, methods, and techniques of under cover narcotics investigations, survellance and drug intradiction; ability to plan and supervise the work of others; ability to participate in sensitive investigative activities and to maintain an impeccable confidentiality in the discharge of the duties of the position; ability to retain the trust and confidence of the District Attorneys, the local Police Chiefs and the members of the Community Policing Unit; ability to effectively interview victims and witness; ability to maintain accurate records

and reports; ability to work effectively with other law enforcement agencies; ability to testify in court and Grand Jury proceedings; ability to analyze evidence and develop investigative leads; ability to make clear and accurate oral and written reports; ability to understand and interpret complex written material; ability to present evidence in physical, written or oral form; good observation skills; integrity and honesty; initiative and resourcefulness; and sound judgment.

# MINIMUM QUALIFICATIONS: Either

- (A) Possession of a bachelors degree in criminal justice and four years of experience as police officer\*, including extensive experience in narcotics investigations, undercover work, electronic surveillance, two years of which shall have involved the supervision of police officers and or investigators in the investigation of criminal offenses; or
- (B) Eight years of experience as described in (A) above, two years of which shall have involved the supervision of other Police Officers; or
- (C) An equivalent combination of training and experience as described in (A) and(B) above.
