DISTINGUISHING FEATURES OF THE CLASS: This position involves responsibility for performing professional and technical duties in support of the County Division of Health and Family Services. Duties will include the compiling and analysis of data, the research into existing rules, regulations, and laws governing current Health and Human Service Plans, and coordinating the planning process. Additionally, the incumbent will perform technical duties in connection with identifying, applying for, and administering state and federal grants for the Division. Work is performed under supervision of the Commissioner of the Division with wide leeway for independently performing most of the duties of the position. The position will involve considerable interaction with division staff, consumers, service providers, and public officials to ensure consolidation and coordination efforts are achieved.

TYPICAL WORK ACTIVITIES: The typical work activities listed below, while providing representative examples of the variety of work assignments in the title, do not describe any individual position. Incumbents in this title may perform some or all of the following, as well as other related activities not described.

Assists in the development of an Integrated County Plan, which is a long range plan of integrating and consolidating the planning and delivery of services to all youth and families, in cooperation with the other human service agencies;

Assists in developing and preparing all human services plans and programs of implementation as required by local, state and/or federal legislation;

Researches appropriate materials and literature related to federal and state aid programs;

Prepares grant applications and proposals for private, state and federal financial assistance on behalf of the county;

Analyzes statistical and other data to determine viability of projects for grant funding;

Coordinates the activities of various local governmental organizations relating to their common interests in applying for grants;

Interfaces with state officials both verbally and in writing, provides them with reports, and coordinates activities with specific state agencies;

Prepares and conducts oral and written presentations to inform legislative bodies, governing boards, agency heads, and the general public concerning the Integrated County Plan;

Acts as liaison to other human services agencies involved in some aspect of the delivery of services;

Coordinates Interagency activities with services offered by other agencies;

On assignment by Commissioner may act as liaison and assures compliance with state agencies reporting requirements;

Develop data bases and spreadsheets to produce financial and programmatic statistical reports as needed;

Travel to conferences, state and regional meetings, community group presentations; Other duties as assigned.

#### FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL

<u>CHARACTERISTICS</u>: a through knowledge of and sensitivity to the characteristics, problems, needs and interests of the youth and communities of this county, working knowledge of the community resources available in the county; good working knowledge of the county's Health and Human Service departments; good knowledge of the principles and practices involved in planning, evaluating and researching information and ability to read, understand and apply

program regulatory materials; ability to establish and maintain effective working relationships with public and private officials and agencies; ability to express oneself clearly, both orally and in writing; ability to prepare a variety of technical and objective materials; ability to work both cooperatively in a team environment as well as work independently; and possess computer skills in both data base spreadsheet development to prepare reports and technical documents.

#### **MINIMUM QUALIFICATIONS:**

- (A) Possession of a Bachelor's degree from a regionally accredited college or university or one accredited by the New York State Board of Regents to grant degrees in planning, economics, social sciences, or a related field and two years of experience in planning, human services, public administration or a related field; at least one year of which must have been in a supervisory capacity or program development and monitoring; or
- (B) Possession of an Associates degree from a regionally accredited college or university or one accredited by the New York State Board of Regents in planning, economics, social sciences, or a related field and four years experience in either planning, human services, or public administration; at least one year of which must have been in a supervisory capacity or program development or monitoring; or
- (C) An equivalent combination of experience and training as defined by the limits of (A) and (B) above.
