DISTINGUISHING FEATURES OF THE CLASS: This is an administrative position involving responsibility for planning, coordinating, supervising and managing the performance and activities of a unit or section of the Income Maintenance, Fair Hearing or Fraud Division in the Family Services Department. Incumbents may also be assigned special training or auditing duties to insure that acceptable levels of staff performance and quality control are maintained. Duties, though similar to those of Principal Social Welfare Examiner are broader in scale, are performed with more independence and involve a greater variety of related functions and the exercise of supervision over a greater number of subordinates. Work is performed under the supervision of the director of the assigned unit.

TYPICAL WORK ACTIVITIES:

Assists in the formulation of local policies and procedures which relate to financial eligibility for the

various programs administered by the local social services districts;

May interview applicants/clients to gather pertinent data in order to make eligibility determination; Reviews difficult or unusual cases and may make independent judgment or decisions;

Interprets Federal, State and local policies and programs as they relate to financial eligibility;

- Trains staff, plans, coordinates, supervises and manages activities within his/her assigned area of responsibility;
- Establishes necessary controls for determining staff performance and makes necessary performance evaluations;

May be assigned quality control functions to insure that error rates are kept at an acceptable level; Maintains contact and cooperative relationships with clients, other units and sections of the agency,

community groups, vendors and other agencies via telephone, correspondence or personal contact to facilitate the delivery of entitlement benefits;

Attends trainings and conferences to keep abreast of changing laws, regulations and policies to diminish fraudulent activities and improve job performances;

May report findings of investigations and make recommendations for proper disposition of cases

(i.e. deduce grant, close case, refer to law enforcement agency, if appropriate);

Provides coverage in absence of other supervisors or examiners, as needed;

May act as a mediator in disputes between subordinate employees and applicants/clients;

Compiles and maintains records and reports for various County and State agencies utilizing

various personal computer software programs.

FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL

<u>CHARACTERISTICS</u>: Comprehensive knowledge of Federal, State and local social services laws and programs as they affect eligibility for financial assistance; comprehensive knowledge of the agency's overall programs, policies and procedures; thorough knowledge of other laws and programs which may affect eligibility such as: Workmen's Compensation, Social Security and Unemployment Insurance; thorough knowledge of modern principles of supervision; ability to communicate and deal effectively with others; good knowledge of interviewing procedures and practices; ability to plan, coordinate, manage and supervise the work of others and to evaluate their performance; ability to prepare reports utilizing personal computer software program; initiative; tact; judgment; leadership; and emotional maturity.
