DISTINGUISHING FEATURES OF THE CLASS: This is a professional position involving responsibility for evaluating, planning and providing occupational therapy treatment on an outpatient basis. The Occupational Therapist is responsible for providing Occupational Therapy to Certified Home Health Agency patients, and Long Term Care patients authorized to receive these services. Work is performed under general direction of the Director of Patient Services and/or a Supervising Public Health Nurse with wide leeway for independently performing most job duties. Supervision may be exercised over the work of other staff performing Occupational Therapy and clerical employees assigned to the service.

TYPICAL WORK ACTIVITIES: The typical work activities listed below, while providing representative examples of the variety of work assignments in the title, do not describe any individual position. Incumbents in this title may perform some or all of the following, as well as other related activities not described.

Evaluates the degree of function and disability of patients unless contra-indicated by professional judgment or a physician's admission notes;

Develops a treatment plan, short and long term rehabilitation goals and in accordance with the physician's diagnosis, prescription or referral;

Records evaluations, reevaluations, progress notes, consultations and discharge summaries.

Performs occupational therapy procedures in accordance with established treatment plan;

May fabricate and apply hand splints, train patients/clients in the use of adaptive devices and/or self-help techniques to achieve maximum independence;

Participates with other Public Health personnel in the formulation of patient's/clients total care plans;

Confers periodically with the Director of Patient Services and/or a Supervising Public Health Nurse and others regarding all facets of patient/client care and related activities;

Develops or assists in the development of occupational therapy policies and procedures;

Assists in the development of, and instructs the Public Health's in-service education program;

Maintains program records including but not limited to the service budget, statistical reports of the

frequency and types of treatment and number of patients treated.
